ORDINANCE 20-10: AN ORDINANCE ADOPTING A POLICY PROHIBITING SEXUAL HARASSMENT FOR THE CITY OF EAST MOLINE, ILLINOIS.

ORDINANCE 20-11: AN ORDINANCE ESTABLISHING TEMPORARY EXECUTIVE POWERS PURSUANT TO CHAPTER 6, ARTICLE I OF THE EAST MOLINE MUNICIPAL CODE AND 65 ILCS 5/11-1-6 OF THE ILLINOIS REVISED STATUTES. (Consideration)
