

Pursuant to the Freedom of Information Act ("FOIA"; 5 ILCS 140/1 et seq), I hereby request disclosure of certain identified public records in the custody and control of the East Moline Planning and Zoning Department. I seek copies of the following documents:

- Complaints, fines, code violations, zoning violations, and property reports filed for the address 1100 3rd St., East Moline, IL 61244 from 2010 to the present.

The requester would prefer that all computerized records be disclosed by sending them as an attachment to the electronic mail address foia29@gmail.com. To the extent that any portions of or any of the public records I seek were not created on and/or are not preserved on electronic media, I seek their disclosure in any form in which they exist including true photocopies thereof.

To the extent that any portions of the public records I seek are exempt from disclosure for privacy or other reasons, I specifically request immediate disclosure of those portions of the public records which are not exempt by disclosing to me a copy of the public records with any exempt portions redacted. In addition, I request a specific explanation of the reasons why any records requested (or portions thereof) are not disclosed.

I stand ready to pay your administration any and all legally permitted fees and costs for the duplication of the public records but, I request notification and my consent prior to the duplication of the records.

Thank you for your cooperation and assistance. Please reply at your earliest convenience (but in no case in excess of the time provided by FOIA) by electronic mail.
