PARTICIPATION WAIVER FORM

I represent to the City of East Moline (hereinafter “the City”) that I am fully authorized to bind the undersigned entrant regarding our entry in the City of East Moline Annual 4th of July Parade. On behalf of the entrant, I agree that our entry and all persons associated with it shall comply with all rules prescribed by the City as deemed necessary for the efficient and safe conduct of the parade and all related activities. I agree to conduct our entry and myself in a proper, appropriate manner during the event and related activities and not to engage in any activity that is dangerous or likely to cause harm, injury or damage to the person or property of others.

I, _____, (name of Participant/Sponsor), do hereby release and discharge the City, its representatives, officials, officers, agents, volunteers, and employees from all claims, demands, and causes of action of every kind whatsoever for any damages and/or injuries which may result from my participation, the participation of my child, or the participation of anyone involved with our entry in the City’s 4th of July Parade as well as any risks associated with such participation.

As a condition of being a participant of the City’s 4th of July Parade, I agree on behalf of all participants in the entry to assume full responsibility for my conduct and the conduct and activities of our entry and to indemnify and hold harmless the City from any liability, claim, loss or expense (including attorney’s fees) caused by or arising from (a) any conduct or negligence by me or any person or part of our entry that causes harm, damage, or injury to myself or others (b) any breach or omission of my representations or warranties, (c) any claim by my participants, employee, subcontractor or supplier, or (d) any infringement or violation by myself or others in the entry of the rights of others.

I, _____, (name of Participant/Sponsor) do voluntarily agree to participate in this Event and acknowledge there may be some hazard of personal accident or injury before, during, or after the event and willingly accept responsibility for any personal injury which may arise from this voluntary participation. The undersigned agrees to hold the City harmless in the event of a personal injury or accident involving any participant of said entry.

In addition, I understand and agree the City cannot be expected to control all possible risks but may need to respond to accidents and potential emergency situations. Therefore, I hereby give my consent for medical treatment that may be required during my attendance, with the understanding that the cost of any such treatment will be my responsibility.

I have read this agreement and do willingly signify my agreement for the consideration expressed and with a full understanding of its purpose by signing below.
